The 14th Amendment guaranteed citizenship and equal rights to all persons born in the United States. This amendment was essential in countering discriminatory Black Codes ...

During the 14th Five-Year Plan period (2021-2025), China's exports of wind and solar products are estimated to have helped other countries cut carbon emissions by around 4.1 billion ...

All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside.
